**CAUTION, READ CAREFULLY.** You must follow every step below and initial the line associated with every step. Failure to follow all of these instructions will disqualify you from hunting within the City of Duluth in 2018.

- Step 1. Complete an approved Bowhunter Education course \_\_\_ YES \_\_\_ NO
- Step 2. Pass a shooting proficiency test in 2018, by *NLT 27 June* \_\_\_ YES \_\_\_ NO
- Step 3. Go to the ABA website and complete the online application \_\_\_ YES \_\_\_ NO
- Step 4. Print off a copy of Part 2 of the Application (online) \_\_\_ YES \_\_\_ NO
- Step 5. Read, sign and date the application in **all three** locations requested. \_\_\_ YES \_\_\_ NO
- Step 6. Write a \$25.00 check or money order made payable to the **City of Duluth** and submit before the 30 June deadline \_\_\_ YES \_\_\_ NO
- Step 7. Print out a copy of this check list \_\_\_ YES \_\_\_ NO  
You do not need to mail in this checklist, but it helps to make sure everything is correct

- Step 9. Make a copy of all of the above for your records. \_\_\_ YES \_\_\_ NO

**STOP** if you responded 'NO' to any question above. Your application is incomplete and will be rejected. This means you will not be hunting in the City of Duluth in 2018. You must complete the above requirements and initial 'YES' to every step before submitting your application.

Dishonored and/or NSF checks will disqualify you from hunting within the City of Duluth in 2018. Your check will not be cashed until sometime in August.

Your complete application, waiver (Part 2) and payment may be mailed to the ABA mailbox (the address above at the UPS Store). Note that UPS store will no longer accept hand-delivered applications. The application package shall arrive at the ABA mailbox no later than 6:00 pm central daylight time on June 30, 2018 to be considered. Exception: applications arriving after this deadline that are postmarked by June 23 will be accepted. After June 23, you are strongly encouraged to hand-deliver your application to Bork at 3987 Five Corners Road, Hermantown.

Hunters who fail to submit a complete application to the Arrowhead Bowhunters Alliance by the application deadline will be rejected for the Hunt. Any prospective hunter who feels their application was erroneously rejected by the ABA may appeal the rejection. The prospective hunter **MUST** follow the Appeals process identified in the ABA Rules Manual, or they will not be considered for the current year's hunt, or the following year's hunt.
