Step 1. Complete an approved Bowhunter Education course _____ YES _____ NO

Step 2. Pass a shooting proficiency test between 1 March and NLT 12 June _____ YES _____ NO

For hunters with 5 or more years of ABA participation, this may be your winter league average or a 3D course scorecard from this year, and may not necessarily be the receipt number from Chalstrom's or Custom Archery.

Step 3. Go to the ABA website and complete the online application _____ YES _____ NO

Step 4. Print off a copy of Part 2 of the Application (online) _____ YES _____ NO

Step 5. Read, sign and date the application in **all three** locations requested. _____ YES _____ NO

Step 6. Write a \$40.00 check or money order made payable to the **City of Duluth** and submit before the **15 June deadline** _____ YES _____ NO

STOP if you responded 'NO' to any question above. Your application is incomplete and will be rejected. This means you will not be hunting in the City of Duluth this fall. You must complete the above requirements and initial 'YES' to every step before submitting your application.

Dishonored and/or NSF checks will disqualify you from hunting within the City of Duluth this year. **Your check will not be cashed until sometime in August.**

Your complete application, waiver (Part 2) and payment may be mailed to the ABA mailbox (the address above at the UPS Store). The application package shall arrive at the ABA mailbox **no later than 6:00 pm central daylight time on June 15** to be considered. Exception: applications arriving after this deadline that are postmarked by June 1 will be accepted. After June 1, you are strongly encouraged to hand-deliver your application to Bork at 3987 Five Corners Road, Hermantown or to the UPS Store on West Central Entrance.

Hunters who fail to submit a complete application to the Arrowhead Bowhunters Alliance by the application deadline will be rejected for the Hunt. Any prospective hunter who feels their application was erroneously rejected by the ABA may appeal the rejection. The prospective hunter **MUST** follow the Appeals process identified in the ABA Rules Manual, or they will not be considered for the current year's hunt, or the following year's hunt.
